**Valid payment must be received at the ECA Office on or before March 31, 2021** (postmarks acceptable) in order to be eligible for the following options and to avoid the 10% surcharge starting April 1<sup>st</sup>.

- **For Individual or Family Memberships Only: Payable in full OR you may make a payment of 33%** of your total fees by cash or check due **by March 31, 2021** and pay the remainder in two equal payments—billed to you by ECA in April and May. **ECA accounts cannot be used for the one-third deposit for golf memberships** unless your purchase is made on or before February 28. (See details below)
- **For all other Memberships or Player Passes: Make full payment by March 31, 2021** using cash, check or credit card (Visa, Mastercard, American Express or Discover).

**AFTER MARCH 31:**

All categories of Memberships, 20-Round Player Passes, 10-Round Player Passes, Seasonal Cart and Trail Fee rates increase by 10% on April 1, 2021.

**THREE-MONTH PAYMENT PLAN: Available to Owners and Public in Good Standing**

Family and Individual memberships only can be paid over a 3-month period. By **March 31, 2021**, pay one-third of membership fees due, by cash or check, and the remaining 2 payments will be billed through your ECA account in April and May. If paying for other services (season cart, locker, bag storage, range or McDonough Scholarship) in addition to membership, these may also be paid in three installments as part of the combined total. Commercial credit cards are not acceptable for this payment plan.

VISA, MasterCard, American Express and Discover cards may be used only for full payment.

**PURCHASES ARE NON-REFUNDABLE:**

Memberships, Player Passes and all ancillary services are sold on a non-refundable basis. However, a full, unlimited Golf Member may be eligible for a partial refund for valid medical disability as defined in detail in the EGL Member Bylaws. **All refund requests for golf memberships must be received in writing prior to August 1, 2021.**

**CLARIFICATIONS TO MEMBERSHIPS, PLAYER PASSES AND MISC CATEGORIES:**

**Family Membership** includes up to two adults and their dependent children, aged 18 and younger as of April 1, 2021, who reside in the same household.

**Junior Membership**—For anyone under the age of 18 as of April 1, 2021. Play any time after 2 p.m. seven days a week. The Golf Shop has the discretion to require an adult to accompany a junior and/or to allow earlier play. Please submit a copy of a valid ID.

**Student Membership**—A student is an individual attending college or other post-secondary educational institution full time **and** under the age of 25 as of April 1, 2021. Students may play seven days a week as tee times allow. Please submit a copy of a valid ID.

**SEASON CART and TRAIL PASSES:**

A cart pass for unlimited cart use is available for Individual and Family members. A Family Cart Pass for two designated drivers can be purchased with a Family Membership. Drivers must have a valid drivers license. Family minors may accompany a designated driver but never drive the cart.

**ALL PLAYER PASSES, MEMBERSHIPS AND GOLF SERVICES ARE NON-TRANSFERABLE AND VALID FOR THE 2021 SEASON ONLY. PLAYING PRIVILEGES MAY BE REVOKED FOR NON-PAYMENT OF OBLIGATIONS AND/OR FAILURE TO COMPLY WITH EGL POLICIES AND PROCEDURES.**
